

## **RISICO'S AND CITY OF FRESNO WORKERS' COMPENSATION PRESCRIPTION INFORMATION**

Risico Claims Management has partnered with **myMatrixx** to make filling workers' compensation prescriptions easy and at no expense to the injured employee. Only medication(s) prescribed by the injured employee's authorized treating physicians for their work related injury will be approved.

After the injured employee receives their prescription from their workers' compensation physician, they should visit any network pharmacy and present their prescription and prescription card. Injured employees are given a temporary prescription card and should receive a permanent prescription card within 3 to 5 business days from the time claim is reported to Risico. The pharmacy will submit the required information to myMatrixx.

### **MOBILE APP WITH PHARMACY LOCATOR:**

In addition to all eligible injured employee's receiving a prescription drug card, they also have the option to instantly download their prescription card information to their mobile phone or other wireless device. Through the **myMatrixx** Mobile App, injured employees can access their pharmacy card details from a smartphone or any internet-enabled device with no waiting.

The myMatrixx Mobile Pharmacy locator feature provides injured employee's with a simple and convenient way to locate an in-network pharmacy close to their home, including interactive driving directions-and their mobile RX e-card provides them with instant access to prescription information to present at the pharmacy.

### **MEDICAL TREATMENT UTILIZATION SCHEDULE (MTUS) DRUG FORMULARY – EFFECTIVE 1.1.18**

The Division of Workers' Compensation (DWC) has adopted (MTUS) Drug Formulary as set forth in Section 9792.27.5 and the formulary rules set forth in Sections 9792.20 through 9792.27.23. Drugs prescribed to treat a work related injury or illness fall within Labor Code section 4600's definition of "medical treatment" and are subject to the relevant provisions of the MTUS, including the MTUS Treatment Guidelines. It is important to know these new rules may affect your claim.

- ✓ The MTUS Drug Formulary applies to drugs dispensed on or after 1.1.18
- ✓ If your date of injury is before 1.1.18 and you are receiving ongoing treatment, a phased in approach will apply to ensure an abrupt change in treatment is avoided
